Ladies and Gentlemen:

The previously negotiated total package increase of 2.65% (per group) per hour effective **June 1, 2023**, has been allocated. The total package increase has been allocated with \$0.34 per hour to Health & Welfare, \$0.25 per hour to Pension, \$0.01 per hour to Training and the remaining to wages.

The wage, fringe and dues increases are effective June 1, 2023. A complete listing of the new wage and fringe benefit rates are on the back of this letter. Should you have any questions regarding any wage or benefit rate, please feel free to call the local union for assistance.
